Subject: Extension of IPSDU Contract

SECC County was scheduled this fall to negotiate our contract with IPSDU. The county was contacted by 2 of our open units to suggest an extension of the contracts. The current economy is in flux due to the pandemic. The CPI in July was at 5.9%. The law regarding negotiation caps what an arbitrator can award to non-public safety units, which includes IPSDU, based on the CPI or 3%, whichever is lower. If we were to go to arbitration in January, 2022 the arbitrator would view the current trend of CPI and per PERB's chart would see the CPI at 5.9% (as is lags 6 months). The assumption would be that we'd see an award of 3%. Based on those predictions we're recommending a one year extension of the open contract and GWI of 3% on July 1, 2022. The remainder of the contracts remain unchanged. IPSDU has ratified this extension.
